

# 1 Author Guidelines for GCPR 2019 Submission 1

4 **Abstract.** The abstract should summarize the contents of the paper. It 4  
5 will be set in 9-point font size and be inset 1.0 cm from the right and left 5  
6 margins. There will be two blank lines before and after the Abstract. 6

## 7 1 Introduction 7

8 Please follow the steps outlined below when submitting your manuscript<sup>1</sup>. 8

### 9 1.1 Language 9

10 All manuscripts must be in English. 10

### 11 1.2 Paper Length 11

12 The maximum allowed paper length is 12 pages without references and 14 pages 12  
13 with references. For example, a paper with 13 pages text and 1 page references 13  
14 exceeds the paper length while a paper with 11 pages text and 3 pages references 14  
15 is within the limits. Over-length papers will be rejected without reviewing. This 15  
16 includes papers where the margins and formatting are deemed to have been 16  
17 significantly altered from those laid down by this style guide. 17

### 18 1.3 Submission and Paper ID 18

19 The paper needs to be submitted via Microsoft CMT before the deadline. After 19  
20 the registration of a paper in the CMT, you will receive a paper ID. The paper 20  
21 ID needs to added to the paper by editing 21

22 `\def\GCPR19SubNumber{PAPERID}.` 22

23 It is also strongly recommended to use the paper ID for the supplementary 23  
24 material (file names, titles, ...). 24

## 25 1.4 Dual Submission 25

26 By submitting a manuscript to GCPR, the authors assert that it has not been 26  
 27 previously published in substantially similar form. Furthermore, no paper which 27  
 28 contains significant overlap with the contributions of this paper either has been 28  
 29 or will be submitted during the GCPR 2019 review period to either a journal or 29  
 30 a conference. 30

31 If there are any papers that may appear to the reviewers to violate this 31  
 32 condition, then it is your responsibility to (1) cite these papers – preserving 32  
 33 anonymity as described in Section 2 of this example paper, (2) argue in the 33  
 34 body of your paper why your GCPR paper is non-trivially different from these 34  
 35 concurrent submissions, and (3) include anonymized versions of those papers in 35  
 36 the supplementary material. 36

## 37 1.5 Supplementary Material 37

38 Authors may optionally upload supplementary material. Typically, this mate- 38  
 39 rial might include result videos that cannot be included in the main paper, 39  
 40 anonymized related submissions to other conferences and journals, and appen- 40  
 41 dices or technical reports containing extended proofs and mathematical deriva- 41  
 42 tions that are not essential for understanding of the paper. Note that the contents 42  
 43 of the supplementary material should be referred to appropriately in the paper, 43  
 44 and that reviewers are not obliged to look at the submitted material. All supple- 44  
 45 mentary material must be either a single PDF or a zip file containing multiple 45  
 46 items. To limit the load on the servers, we ask authors to either submit the 46  
 47 supplementary material well before the main paper deadline, or after the main 47  
 48 paper deadline. 48

## 49 1.6 Line Numbering 49

50 All lines should be numbered, as in this example document. This makes reviewing 50  
 51 more efficient, because reviewers can refer to a line on a page. 51

## 52 1.7 Mathematics 52

53 Please number all of your sections and displayed equations. Again, this makes 53  
 54 reviewing more efficient. Also, it is important for readers to be able to refer to 54  
 55 any particular equation. Just because you didn't refer to it in the text doesn't 55  
 56 mean some future reader might not need to refer to it. It is cumbersome to have 56  
 57 to use circumlocutions like “the equation second from the top of page 3 column 57  
 58 1”. (Note that the line numbering will not be present in the final copy, so is not 58  
 59 an alternative to equation numbers). 59

## 2 Blind Review

Many authors misunderstand the concept of anonymizing for blind review. Blind review does not mean that one must remove citations to one's own work – in fact it is often impossible to review a paper unless the previous citations are known and available. Blind review means that you do not use the words “my” or “our” when citing previous work. That is all. (But see below for technical reports).

Saying “this builds on the work of Lucy Smith [1]” does not say that you are Lucy Smith, it says that you are building on her work. If you are Smith and Jones, do not say “as we show in [7]”, say “as Smith and Jones show in [7]” and at the end of the paper, include reference 7 as you would any other cited work.

- An example of a paper that violates the guidelines:

*In this paper we present a performance analysis of our previous paper [1], and show it to be inferior to all previously known methods. Why the previous paper was accepted without this analysis is beyond me. [1] Removed for blind review*

- An example of a paper well prepared for blind review:

*In this paper we present a performance analysis of the paper of Smith [1], and show it to be inferior to all previously known methods. Why the previous paper was accepted without this analysis is beyond me. [1] Smith, L and Jones, C. “The frobnicatable foo filter, a fundamental contribution to human knowledge”. *Nature* 381(12), 1-213.*

If you are making a submission to another conference at the same time, which covers similar or overlapping material, you may need to refer to that submission in order to explain the differences, just as you would if you had previously published related work. In such cases, include the anonymized parallel submission [5] as additional material and cite it as

Finally, you may feel you need to tell the reader that more details can be found elsewhere, and refer them to a technical report. For conference submissions, the paper must stand on its own, and not *require* the reviewer to go to a technical report for further details. Thus, you may say in the body of the paper “further details may be found in [6]”. Then submit the technical report as additional material. Again, you may not assume the reviewers will read this material.

Sometimes your paper is about a problem which you tested using a tool which is widely known to be restricted to a single institution. For example, let's say it's 1969, you have solved a key problem on the Apollo lander, and you believe that the GCPR audience would like to hear about your solution. The work is a development of your celebrated 1968 paper entitled “Zero-g frobnication: How being the only people in the world with access to the Apollo lander source code

makes us a wow at parties”, by Zeus. You can handle this paper like any other. Don’t write “We show how to improve our previous work [Anonymous, 1968]. This time we tested the algorithm on a lunar lander [name of lander removed for blind review]”. That would be silly, and would immediately identify the authors. Instead write the following:

*We describe a system for Zero-g frobnication. This system is new because it handles the following cases: A, B. Previous systems [Zeus et al. 1968] didn’t handle case B properly. Ours handles it by including a foo term in the bar integral. . . . The proposed system was integrated with the Apollo lunar lander, and went all the way to the moon, don’t you know. It displayed the following behaviours which show how well we solved cases A and B: . . .*

As you can see, the above text follows standard scientific convention, reads better than the first version, and does not explicitly name you as the authors. A reviewer might think it is likely that the new paper was written by Zeus, but cannot make any decision based on that guess. He or she would have to be sure that no other authors could have been contracted to solve problem B.

Since acknowledgements are not relevant for reviewing and violate blind review, please **omit acknowledgements**. The acknowledgements can be added to the final copy.

### 3 Manuscript Preparation

This is an edited version of Springer LNCS instructions<sup>2</sup> adapted for GCPR 2019 paper submission. You have to use L<sup>A</sup>T<sub>E</sub>X2<sub>ε</sub> for the preparation of your camera-ready manuscript together with the corresponding Springer class file `llncs.cls`. We would like to stress that the class/style files and the template should not be manipulated and that the guidelines regarding font sizes and format should be adhered to. This is to ensure that the end product is as homogeneous as possible.

#### 3.1 Printing Area

The printing area is 122 mm × 193 mm. The text should be justified to occupy the full line width, so that the right margin is not ragged, with words hyphenated as appropriate. Please fill pages so that the length of the text is no less than 180 mm.

#### 3.2 Layout, Typeface, Font Sizes, and Numbering

Use 10-point type for the name(s) of the author(s) and 9-point type for the address(es) and the abstract. For the main text, please use 10-point type and

single-line spacing. We recommend using Computer Modern Roman (CM) fonts, Times, or one of the similar typefaces widely used in photo-typesetting. (In these typefaces the letters have serifs, i.e., short endstrokes at the head and the foot of letters.) Italic type may be used to emphasize words in running text. Bold type and underlining should be avoided. With these sizes, the interline distance should be set so that some 45 lines occur on a full-text page.

**Headings.** Headings should be capitalized (i.e., nouns, verbs, and all other words except articles, prepositions, and conjunctions should be set with an initial capital) and should, with the exception of the title, be aligned to the left. Only the first two levels of section headings should be numbered, as shown in Table 1. The respective font sizes are also given in Table 1. Kindly refrain from using “0” when numbering your section headings. Words joined by a hyphen are subject to a special rule. If the first word can stand alone, the second word should be capitalized.

**Table 1.** Font sizes of headings. Table captions should always be positioned *above* the tables.

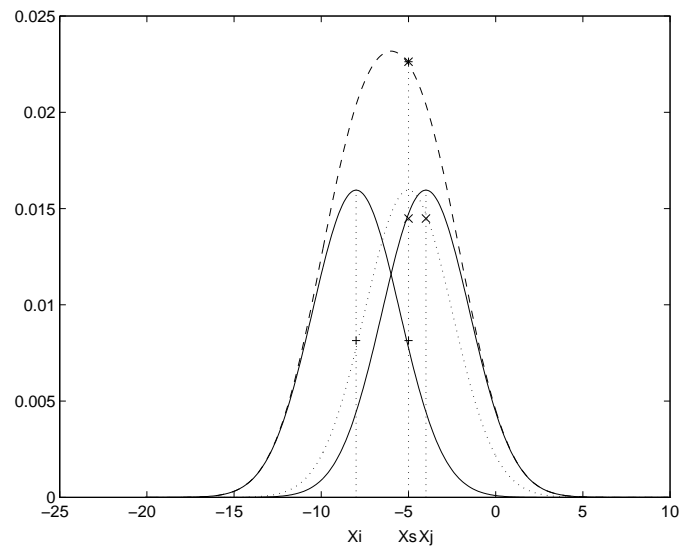
Heading level	Example	Font size and style
Title (centered)	<b>Lecture Notes ...</b>	14 point, bold
1st-level heading	<b>1 Introduction</b>	12 point, bold
2nd-level heading	<b>2.1 Printing Area</b>	10 point, bold
3rd-level heading	<b>Headings.</b> Text follows ...	10 point, bold
4th-level heading	<i>Remark.</i> Text follows ...	10 point, italic

Here are some examples of headings: “Criteria to Disprove Context-Freeness of Collage Languages”, “On Correcting the Intrusion of Tracing Non-deterministic Programs by Software”, “A User-Friendly and Extendable Data Distribution System”, “Multi-flip Networks: Parallelizing GenSAT”, “Self-determinations of Man”.

**Lemmas, Propositions, and Theorems.** The numbers accorded to lemmas, propositions, and theorems etc. should appear in consecutive order, starting with Lemma 1. Please do not include section counters in the numbering like “Theorem 1.1”.

### 3.3 Figures and Photographs

Please produce your figures electronically and integrate them into your text file. Integrate images by using the package `graphicx` or the style files `psfig` or `epsf` and define figures as floating objects. Please avoid using the location parameter “h” for “here”.



**Fig. 1.** One kernel at  $x_s$  (*dotted kernel*) or two kernels at  $x_i$  and  $x_j$  (*left and right*) lead to the same summed estimate at  $x_s$ . This shows a figure consisting of different types of lines. Elements of the figure described in the caption should be set in italics, in parentheses, as shown in this sample caption.

It is essential that all illustrations are clear and legible. Vector graphics (rather than rasterized images) should be used for diagrams and schemas whenever possible. Please check that the lines in line drawings are not interrupted and have a constant width. Grids and details within the figures must be clearly legible and may not be written one on top of the other. Line drawings are to have a resolution of at least 800 dpi (preferably 1200 dpi). The lettering in figures should not use font sizes smaller than 6 pt (2 mm character height). Figures are to be numbered and to have a caption which should always be positioned under the figures, in contrast to the caption belonging to a table, which should always appear above the table. Captions are set in 9-point type. If they are short, they are centered between the margins. Longer captions, covering more than one line, are justified (Fig. 1 shows an example). Captions that do not constitute a full sentence, do not have a period. Text fragments of fewer than four lines should not appear at the tops or bottoms of pages, following a table or figure. In such cases, it is better to set the figures right at the top or right at the bottom of the page.

### 3.4 Formulas

Displayed equations or formulas are centered and set on a separate line (with an extra line or half line space above and below). Displayed expressions should be numbered for reference. The numbers should be consecutive within the con-

tribution, with numbers enclosed in parentheses and set on the right margin.  
Please do not include section counters in the numbering.

$$\psi(u) = \int_o^T \left[ \frac{1}{2} (A_o^{-1}u, u) + N^*(-u) \right] dt . \quad (1)$$

Equations should be punctuated in the same way as ordinary text but with a small space before the end punctuation mark.

### 3.5 Footnotes

The superscript numeral used to refer to a footnote appears in the text either directly after the word to be discussed or – in relation to a phrase or a sentence – following the punctuation sign (comma, semicolon, or period).<sup>3</sup>

### 3.6 Citations

For citations in the text, please use square brackets and consecutive numbers. We would write [2–6] for consecutive numbers and [2, 4, 6] for non-consecutive numbers. The numbers in the bibliography section are without square brackets. Springer standardizes the format of the references and references that do not adhere to the LNCS style will be reformatted. We would like to draw your attention to the fact that references to LNCS proceedings papers are particularly often reformatted due to missing editor names or incomplete publisher information. This adjustment may result in the final papers as published by Springer having more pages than the original versions as submitted by the authors. Here is an example:

- Reference as formatted in author’s original version:

*Assemlal, H.E., Tschumperlé, D., Brun, L.: Efficient Computation of PDF-Based Characteristics from Diffusion MR Signal. In: MICCAI. Volume 5242. (2008) 7078*

- Reference after reformatting by Springer:

*Assemlal, H.E., Tschumperlé, D., Brun, L.: Efficient Computation of PDF-Based Characteristics from Diffusion MR Signal. In: Metaxas, D., Axel, L., Fichtinger, G., Székely, G. (eds.) MICCAI 2008, Part II. LNCS, vol. 5242, pp. 7078. Springer, Heidelberg (2008)*

One more line is needed for this reference, as a result of Springers adjustment. Please make sure that all your sources are correctly listed in the reference section. Do not include references to pieces of work that are not connected with your paper. In the references are examples for a journal article [7], an LNCS chapter [11], a book [8], a paper in a proceeding without editors [9], a technical report [10], as well as a URL [1]. Please note that proceedings published in LNCS are not cited with their full titles, but with their acronyms.

### 3.7 Plagiarism

Plagiarism is a serious violation of the submission guidelines. Even in the very unlikely case that plagiarism is not discovered during the reviewing process, the paper will be retracted at any time in case of plagiarism. If an author has copied from another author or has used parts of another author's work (text, tables, figures, etc.), without his or her permission and a reference, then the paper on SpringerLink will be given a "retracted" stamp, and an erratum explaining the reasons for the retraction will be included. In addition, the volume editors and the author's academic supervisors will be informed that plagiarism has been committed. Please note that a retracted paper remains visible, with its "retracted" stamp. It does not simply disappear.
